#### 1. Items 4(a) and (b) of Schedule 13G

As of December 31, 2022, the American Fund was the legal owner of 1,486,220 shares of Common Stock. Based on there being 28,603,412 shares of Common Stock outstanding as of October 27, 2022, the American Fund's holding represents approximately 5.2% of the outstanding Common Stock.

The Manager serves as investment manager to the American Fund and has discretionary and voting power over the shares held by the American Fund. Accordingly, the Manager may be deemed to be the beneficial owner of 1,486,220 shares of Common Stock which are held by the American Fund.

The Manager disclaims beneficial ownership of the shares of Common Stock of the Issuer held by the American Fund, except to the extent of any pecuniary interest therefrom, and this report shall not be deemed to be an admission that it is the beneficial owner of such securities.

#### 2. Item 4(c) of Schedule 13G

As of December 31, 2022, each of the Manager and the American Fund may be deemed to have the power to vote or to direct the voting of and to dispose or to direct the disposition of the 1,486,220 shares of Common Stock held by the American Fund.

The Manager disclaims beneficial ownership of the shares of Common Stock of the Issuer held by the American Fund, except to the extent of any pecuniary interest therefrom, and this report shall not be deemed to be an admission that it is the beneficial owner of such securities.
