"Alpine represents a compelling opportunity for us to enhance our presence in Wisconsin through a complementary business with strong local brands, exceptional customer loyalty and a strong management team. This acquisition brings our total acquired revenue in 2016 to approximately \$44 million, as we remain focused on selectively acquiring market-leading installers in highly attractive markets."
