Founded in 1986, GCP is headquartered in Colorado Springs, Colorado and primarily installs drywall, framing, ceiling tiles, and firestopping/insulation for commercial customers. IBP also today announced the acquisition of Reliable Glass & Mirror, LLC, a Louisiana based provider of glass and mirror installation services to residential and commercial customers.

"With approximately \$11.5 million of annual revenue, GCP further expands our commercial installation services to the compelling Colorado Springs market," stated Jeff Edwards, Chairman and Chief Executive Officer. "We also recently acquired Reliable Glass & Mirror increasing our presence within Louisiana. To date in 2021, we have acquired approximately \$79 million of annual revenues. Acquisitions remain a key component of our growth strategy and we continue to have a robust pipeline of acquisition opportunities across multiple geographies, products, and end markets.
