Founded in 2001, Water-Tite provides commercial waterproofing installation services in the Tampa, Florida market and has annual revenue of over \$6.0 million.

During 2018, Alpha opened a branch in Tampa to capitalize on favorable trends within this market and Water-Tite will immediately expand Alpha's presence in the Tampa market. So far this year we have closed nine acquisitions representing nearly \$60.0 million of acquired revenues. Acquisitions remain a key component of our growth plan and we continue to have a robust pipeline of acquisition opportunities across multiple geographies, products and end markets," stated Jeff Edwards, Chairman and Chief Executive Officer.
