“With \$5.0 million of annualized revenues, 3R Products & Services expands our product mix in the Indianapolis market, by adding an extensive line of shower doors, shelving, mirrors, and bath accessories,” stated Jeff Edwards, Chairman and Chief Executive Officer. “2016 has been a tremendous year of acquisition growth, as we focus on enhancing our geographic reach in strong real estate markets, while expanding our product mix to increase the amount of content we provide customers. 3R Products & Services represents the 10th announced acquisition of 2016 and our pipeline of potential acquisitions remains robust.”
